

#### There are 3 entities within Epsilon Sigma Alpha

We are in the business of making money to benefit others.

#### What are the 3 entities?

1) ESA International Council, 2) ESAMC, 3) ESA Foundation

#### What is the International Council?

o It is the entire body of ESA membership belonging paying dues to IC.

#### What is IC Executive Board?

- It's the governing body of ESA International Council comprised of for State Councils, Chapters, Districts, and Regional Councils and ESA members who pay dues to the International Council.
  - Leadership of this body consists of 8 annually elected ESAMC members for:
    - President, 1<sup>st</sup> Vice, 2<sup>nd</sup> Vice, Rec. Sec., Corres. Sec., Treas., Parliamentarian, Workshop Coordinator, Jr. Past Pres.
    - appointed Chair positions, Sr. Past Pres., and the ESA HQ Rep..

#### What is the purpose of ESA International?

 Founded in 1929 it is a powerful network of people who, as individuals or members of ESA's nearly 800 local chapters throughout the USA, Canada and Australia who donate nearly 860,000 hours and raise more than \$15 million annually in cash and pledges to worthy causes.

#### \* What is the 'ESAMC'?

- <u>E</u>psilon <u>Sigma Alpha Membership <u>C</u>orporation.
  </u>
- The governing body is the ESAMC Board consisting of nine voting members; including a rep. from the IC Exec. Board, a rep. from the ESA Foundation and the Exec. Director of the ESAMC (now Charlotte Carloni), chapter members who do not serve as representatives of any other governing boards. Term of service to the ESAMC Board is 3-year terms (limited to 2 consecutive terms). The rep. from the ESA Foundation serves a 1-year term by virtue of their office or as designated annually. The ESA Exec. Director (now Charlotte Carloni) serves for his/her tenure in that position.
- The Membership Corporation is organized solely for the purposes of benefiting the membership. Their mission is to promote, build and advance the good works and best interests of Epsilon Sigma Alpha International.

#### \* What do the ESAMC Board of Directors do?

- They oversee the budget for the ESA Headquarters and set priorities for the program development and for work of those at ESA HQ office. The Board also works to do strategic planning for the use of the resources provided by the membership and works to develop continuity in membership services for the long-term development of these resources. All of the ESAMC Board's efforts are focused on building long term strength for the organization and its ESA Headquarters office.
- ESA members wishing to serve on the ESAMC Board are encouraged to contact Board members to indicate their interest in serving. Future applicants will be considered on the basis of the strengths and skills they can contribute to the board. Applicants do not need to have served on any other ESA board or in any specific ESA office in order to receive consideration for service on the ESAMC Board.

#### What is the ESA Foundation?

- It is a non-profit/tax-exempt organization pledged to develop the philanthropic activities of volunteers, provide assistance to established programs that serve human needs and programs to improve the quality of life.
- Did you know you don't have to belong to ESA to belong the ESA Foundation?

- ❖ Have you ever said: "We're a Non-Profit sorority and we give to St Judes"?
  - o Did you know you weren't telling the truth and why?
  - ✓ The ESAMC pay taxes on the building/land we rent or own.
  - ✓ The ESAMC pays payroll taxes for the employees at the ESA HQ
  - ✓ The ESAMC is, in fact, a business; run as such and listed as such in the records of the IRS
    - i. Because its 'business' is to aid and coordinate ESA members in making money for charities... it makes no profit for itself.
    - ii. Because it makes no profit for itself... the IRS allows it to be a 'NOT-FOR-PROFIT' (a 501©4 coded business) designated business and it does NOT pay income tax.

If audited or asked by the IRS, at any time, the ESAMC must be able to document and prove it has not violated its IRS status by making money *not* being used to aid and coordinate ESA members abilities to make money for charities.

This explains the reason annual Tax Facts is mandatory reporting!

In 1970, or there about, some extremely far-sighted ESA women gathered together their collective wisdom and created the ESA World Center Foundation. That entity is now known only as the ESA Foundation.

In addition to funding and giving Grants and Scholarships annually, the ESA Foundation provides a venue for ESA members and others to expand their charitable giving, utilize Planned Giving, receive legal tax deductions while ensuring their legacies will be handled by a caring and reputable organization helping others into the future.

<u>The ESA Foundation is a NONPROFIT/TAX EXEMPT organization</u> pledged to develop philanthropic activities of volunteers, provide assistance to established programs that serve human needs and produce new programs to improve the quality of life.

The Internal Revenue Service has ruled that the ESA Foundation is exempt from federal income tax under section 501©3 of the Internal Revenue code as an organization operating exclusively for charitable and educational purposes.

Because of its status with the IRS the ESA Foundation enables the ESAMC membership, member State Councils, member Chapters, member Districts, member Regions and others to validate their purpose in raising and giving money to legally designated 501© 3 charitable organizations.

All realize ESA members give to other than 501@3 charitable causes. There is no restriction, with due diligence as to the appropriateness of those charitable donations.

We do represent a nationwide, and documented organization known for its ability to raise money for charitable causes and that brings with it the tacit responsibility to also include donations to our International Projects:

St Jude Children's Research Hospital, Easter Seals, and Hope for Heroes

#### The BOTTOM LINE....

When you request donations to ESA, for any reason, you may NOT say you are a NONPROFIT-TAX EXEMPT organization.

You may <u>NOT</u> tell anyone

"you can take it off your income tax"!!

if they ask... you may say, "you'll need to ask your CPA

or tax consultant about that".

You MAY say: "we are a <u>not-for-profit;</u> a 504©4 status organization raising funds for charitable causes".

(St Jude, Easter Seals, Billy-Bob's hospital fund, etc.)

If the money you are raising will be going to a 501©3 charity (try here:

<a href="https://www.guidestar.org/NonprofitDirectory.aspx">https://www.guidestar.org/NonprofitDirectory.aspx</a> to get the EIN#) then you may ask the donations be made payable to the 'ESA Foundation' (have the specfic charity noted on the "For" line ...bottom left corner of check) and send your collected donations through the Foundation's Turn Around Fund. (a check will be returned to you almost immediately made payable to the charity and you can, in turn, present it or mail it to that charity)

We, (ESA Members, States, Chapters, Districts, Regions), are NOT a charity.

AND... Remember we are a 'business'.

(a really terrific and special business)

#### As for 2018 reporting, here's what I found...

Beginning January 1, 2018, the standard mileage rates for the use of a car (vans, pickups or panel trucks) will be: **54.5 cents per mile** for business miles driven, up from **53.5 cents** for 2017. 18 cents per mile driven for medical or moving purposes, up from 17 cents for 2017.

#### **A Question about Receipts to Donors**

Awhile ago one of our chapters asked about giving receipts to Donors
when we ask for donations to and for our money-making events.

Below you will find the answer given by our own Doug Mills, HQ Accountant and Registered

Agent

for the ESA Foundation.

His qualifications and training are more than adequate for his advice to be listened to.

#### Below is his answer:

- 1. The deductibility of tangible personal property (non-cash) is determined by (at the minimum):
- a. To whom the gift was given (if it's given to anything other than a 501 c 3 nonprofit (like ESAFoundation), it is not deductible). This means if the gift is being given to a chapter or council of ESA, it is not tax deductible.
- b. The amount of the deduction, if it is gifted to a 501 c 3, is determined by its fair market value at the time of the gift. Therefore, you would have to have an appraisal of the gift by someone in the position (expert) of determining that value.
- 2. Not ever being privy to the exact nature of a given transaction, I rarely, if ever, give personal tax advice. As such,
- 3. I advise the Board of Directors of the ESAFoundation to follow suit.

For the above reasons, I advise ESA chapters, councils to not give receipts. If you decide to go ahead and give a receipt, make sure you make no mention of the amount of the gift or the deductibility of said gift.

Please know I wish we could claim charitable status for all of ESA but that is just not the case.
