In addition I prepared the prayers before meals and also the "Thought of the Day" before meetings and sent articles to be printed in the Grapevine.

I prepared the Memorial Service which will be held Sunday Morning.

Documents/Parliamentarian- Kathy State, Sr. chair.

During the past year the documents committee has met quarterly to update the Guidelines and work on a proposed change in the policy and procedures for the Leadership/winter meeting. A Proposal for change is in the mail boxes and will be published in the Grapevine for a vote to be taken at Leadership in the Fall.

Our proposal is based on the lower attendance at these meetings and the increased costs of facilities. In order to keep registration fees reasonable, we are recommending that it is no longer feasible to provide a room for State President. The State Presidents registration will still be included in the budget. We are also increasing the fee for late registration to \$10.00 and changing the time that the final financial report is due. It will be due 30 days after the event.

We have also reviewed many of the elected board positions and still have a couple more to complete. We presented a workshop at the Fall Leadership meeting highlighting many of the forms and guidelines we have updated.

I wish to thank all the chairmen who have made suggestions for additions, clarifications, and changes in our Guidelines. They helped make the work go smoother. My committee members, Connie Russell, Debbie Sanguras, Donna Cassidy, Marsha Klosterman, and Sandy Diess have been wonderful to work with.

They come to the meeting prepared to work, and with wonderful input and good discussion points. Together we have been able to update and change things that we hope are easier to use and reflect the current status.

We will be meeting in June, so if you feel your position has something we need to look at please let us know. We are available for questions you may have.

Policy and procedure for Leadership/winter meeting.

Because of low attendance and high cost of facilities, the Documents Committee was asked to review the Policy and Procedure for Leadership/Winter meetings. After much discussion we decided to recommend the following changes.

Current #3 and 4:

- 3. It is the responsibility of the Leadership/Winter meeting chair as instructed by the State President, to assure registration and lodging for the following: State President, IC Representative(s) and Headquarters Representative (if one is attending).
- 4. The registration is established at the cost of the facility plus the cost of the medium-priced meals including gratuity, and \$10.00 for incidentals. An additional amount per member will be added to registration is a "set up fee" is charged.

Change to 3. It is the responsibility of the Leadership/Winter meeting chair to establish a budget for registration cost of the State President. The registration is established at the cost of the facility plus the cost of the medium-priced meals including gratuity, registration for the State President and \$10 for

incidentals. And additional amount per member will be added to the registration if a "set up fee" is charged.

Reason: The increases hotel costs and inability to receive comped rooms, has increased registration fees. This causes a reduced number of registrants and makes it difficult for chapters to break even. Number 3 and 4 have been combined and all numbers changed.

Current #6 The deadline for registration is two (2) weeks before Leadership/Winter meeting. If this deadline for registration is not met, the member pays and additional five dollars (\$5.00) fee. Refunds will be the registration fee minus ten dollars (\$10.00) operating cost.

Change to: 5 The deadline for registration is two (2) weeks before Leadership/winter meeting. If this deadline is not met, the member pays an additional ten dollars (10.00) fee. Refunds will be registration fee minus ten dollars (\$10.00) operating cost.

Reason: Because of increased costs, the \$10.00 is reasonable.

Current #9 A final Leadership/Winter meeting report shall be forwarded by November 15th to the State President, the first Vice-President, the Workshop Coordinator and the State Recording Secretary.

Change to 8: A final Leadership/Winter meeting report shall be forwarded within 30 days of the event to the State President, the First Vice-President, the Treasurer and the State Recording Secretary.

Reason: Dates of the event are not the same each year and 30 days after the event gives time to compile and distribute the report.
