ESA FOUNDATION -Chris York

Turnaround Funds: Important to the foundation to help strengthen 501c3 status. Rather than sending individual checks to one or more 501c3 charities, you send one check to Foundation indicating which charity is to receive what amount. The Foundation turns around this request and sends individual checks back to the person using the turnaround funds. Then the person sends checks to the individual charities. Benefit – Easier to document donations on your taxes. Last year we donated \$358,445 and yet only \$4,222 went through the turnaround fund. Forms are found in the yearbook. Membership Dues; 59.00 a year or \$500.00 for life active, no more dues. I have a list who needs to pay or if you are good. Since May 1st we have donated \$5239.49. Last year we donated \$11,675. Since we have already donated almost half of last year, we should have no difficulty surpassing last year.

The ESAF FundFest purse this year is a MARY FRANCES one-of-a-kind designer bag. The bag is valued at \$295. Oregon's purse last year when for \$1,100 at the auction.
